FC54.0/23 REPORT FROM MAYOR

- e. Letter of thanks from Ms. Y. Gardner on behalf of Chilton Academy for the grants towards their Community Garden.

FC62.0/23 PLANNING

1 application was considered, and no objection raised, DM/23/01200/PNS Derek Parnaby Limited. Cllr. V.Collinson declared an interest due to family employed by the company and took no part in the item.

FC63.0/23 MONTHLY FINANCIAL RECONCILIATION

It was proposed Cllr. J. Cairns seconded by Cllr. S.Sutherland and agreed to accept the relevant documents and to approve payment of all invoices.

The Town Clerk advised the first indication of the 2024/25 Tax Base has arrived showing a potential increase of 4.8 properties resulting in £1067.71 increase.

Members considered a Community Grant application from Chilton Age Concern for a grant of £400 to assist in member activities. It was proposed Cllr. J. Cairns seconded by Cllr. S.Sutherland and agreed to award this grant. Clerk to present an update on the Community Fund to the September Policy and Resources Committee.

FC 64.0/23 CDALC ANNUAL GENERAL MEETING OFFCER NOMNATIONS

Members noted the letter, but no nominations made.

FC 65.0/23 LETTER BOX FOR LETTERS TO HEAVEN

Cllr. P.Malpas advised she had been approached by residents wishing to fundraise and provide a post box for the Cemetery linked to the Fishburn and Gedling Project. Members were concerned how the actual letters privacy was ensured. It was proposed Cllr. P.Malpas seconded Cllr. S.Sutherland to advise the residents Council agree in principle but need to seek advise regarding privacy of the letters. This was carried. Cllr. P.Malpas also agreed to the residents they will need to raise funds for both the post box and notification memorial stone.

FC66.0/23 EXCLUSION OF PRESS AND PUBLIC

Cllr. J. Cairns proposed and Cllr. S.Sutherland seconded and agreed to exclude press and public for the remainder of the meeting.

FC67.0/23 DISPUTED LAND

Town Clerk gave members an update on damage caused in front of the land at an estimated cost of repair/loss of £300. It was agreed to refer the matter to Council Solicitors for legal redress.

Town Clerk gave members a report on an issue that had occurred regarding the Cemetery. It was agreed a panel of members be established to investigate and report back to a special meeting of the Council 8th August 2023. It was moved Cllr. S.Sutherland seconded Cllr. M.Young suspend services from current contractor till matter resolved. This was carried.
